State licensure Requirements

The following requirements must be completed in order to be recommended to the state for Teacher licensure.

- Basic Academic Skills Assessment (BASA): Pearson Essential Academic Skills or Praxis Core Academic Skills For Educators Exam required. Passing BASA Exam scores or current NH teaching certification must be submitted prior to completion of EDC 800 Introduction to Clinical Experience to continue with clinical courses.
- Licensure Exams: Pearson Special Education and Pearson Foundations of Reading exams required. Students must attempt to pass these exams prior to taking the Culminating Teaching Experience & Seminar. Passing exam scores are required for state licensure.
